The Ellsworth City Council met in regular session at 6:00 p.m. at City Hall on April 22nd,, 2025 with Mayor Yager presiding, and the following council present: Sogard, Phipps and Olson. With Funk arriving at 6:10pm. Also in attendance were Linda Clark with ECA, Ottie Maxey with Ames Regional Economic Alliance, and Chris Kehoe with The Trashman.

PUBLIC FORUM: None Present

DISCUSSION AND POSSIBLE ACTION - ON FISH FARM TIF REBATE: Ottie Maxey with Ames Regional Economic Alliance was present to discuss with the council the economic benefit to having the Fish Farm facility purchased and in use. Data for impact on the general fund by offering a TIF incentive to a potential buyer was also discussed. Motion by Sogard and seconded by Phipps for Clerk Eckers to draft a memo containing Ellsworth's interest in offering a 10 year \$67,000 TIF incentive to a potential buyer contingent upon utility impact changes being made by the buyer prior to operation as well as the nature of business to be conducted in the facility. Roll call votes 4-0. Motion carried.

DISCUSSION AND POSSIBLE ACTION – MEMBERSHIP TO HAMILTON COUNTY GROWTH PARTNERSHIP: Motion by Sogard to pay first year membership at \$500 level to the Hamilton County Growth Partnership. Seconded by Funk. Roll call votes 4-0. Motion carried.

DISCUSSION AND POSSIBLE ACTION – DEVELOPER'S AGREEMENT PARCEL 40872436226006: Motion by Phipps to approve proposed developer's agreement drafted by Schlottfeldt Engineering, seconded by Sogard. Roll call votes 4-0. Motion carried.

ELLSWORTH COMMUNITY ASSOCIATION: Linda Clark, ECA Treasurer and council woman Marcy Olson, ECA President discussed with council some ideas to improve the citywide "Dump Your Junk" event. Chris Kehoe of The Trashman was also present to offer insight on details regarding a weekend-long, potential curbside pickup cleanup event in Ellsworth. The weekend of June 21st was discussed as a doable weekend for The Trashman's schedule and ECA event schedule.

FIRE/EMS: None Present

LIBRARY: None Present

PLANNING AND ZONING APPOINTMENT: Mayor Yager appointed Alyssa Zimmerman of Ellsworth to join the Ellsworth Planning and Zoning Board. Fellow board members include: Beth Grove, Brian Zimmerman, Paula Newman, and Jim Maxwell.

FY 25/26 BUDGET PUBLIC HEARING: Mayor Yager opened the FY 25/26 Budget Public hearing. After giving the public opportunity to be heard, Mayor Yager closed the FY 25/26 Budget Public hearing. Motion by Funk and second by Olson to adopt Resolution #04-22-25 and the 25/26 Budget and Certification of taxes. The total tax levy will be 10.199, with revenues and transfers equaling \$2,471,353 and total expenditures and transfers equaling \$2,718,759. Roll call votes 4- 0. Motion carried.

SETTING PUBLIC HEARING FOR FY24/25 BUDGET AMENDMENT: Motion by Funk and second by Olson to set 24/25 Budget amendment hearing for 6pm on May 27th. Roll call votes 4-0. Motion carried.

DISCUSSION AND POSSIBLE ACTION – SALE OF BINGO TABLES AND CHAIRS TO KAMRAR LIONS CLUB: Motion by Phipps and second by Sogard to sell the remaining Bingo tables and chairs to the Kamrar Lion's club for \$90. Roll call votes 4-0. Motion carried.

**PUBLIC WORKS: DISCUSSION AND POSSIBLE ACTION – ELECTRIC UTILITY IMPROVEMENTS TO 101 HWY 175:** Supervisor Vanlangen discussed with Council the upcoming electric infrastructure project involving expansion of the Ellsworth Car and Truck Wash. A Midland Power quote was also discussed for these improvements. Council discussed the property no longer being in the Urban Renewal District and therefore, no TIF funds could be utilized to pay for the infrastructure expenses. Prior business expansion projects have resulted in a shared cost of boring and the business paying for additional transformers required for their project. Motion by Funk and seconded by Sogard to have the city pay for wire and boring along the city easement and the business as an existing and expanding enterprise, paying for the remaining portion of wire, boring, and for the transformer. Roll call votes 4-0. Motion carried. Clerk Eckers will draft an invoice including these parameters for payment.

**PUBLIC WORKS: DISCUSSION AND POSSIBLE ACTION – FY 25/26 PURCHASE OF NEW BACKHOE:** Discussion between Public Works Supervisor Vanlangen and the Council concerning the need for a new backhoe. Council requested more purchase or lease options prior to making a decision. Agenda item tabled.

**CITY HALL UPDATES – DISCUSSION AND POSSIBLE ACTION: APPOINTING A MODERATOR FOR UPCOMING TOWN HALL:** Councilman William Funk appointed as Moderator for April 27 Town Hall at the Ellsworth Community Center.

**CITY HALL UPDATES - DISCUSSION AND POSSIBLE ACTION: CITY HALL MERCHANT PROCESSING:** Motion by Sogard and second by Olson to accept proposal by Professional Solutions Financial Services to an in-house credit card processing system for City Hall. Roll call votes 4-0. Motion carried.

**ADJOURNMENT:** Mayor Pro Tem Funk adjourned the meeting at 9:08 pm.

**FY 25/26 BUDGET ADOPTION:** Mayor Yager opened the FY 25/26 Budget Public hearing. After giving the public opportunity to be heard, Mayor Yager closed the FY 25/26 Budget Public hearing. Motion by Olson and second by Sogard to adopt Resolution #04-22-25 and the 25/26 Budget and Certification of taxes. The total tax levy will be 10.199, with revenues and transfers equaling \$2,471,353 and total expenditures and transfers equaling \$2,718,759. Roll call votes 3-0. Motion carried.

## MAY 12th CITY COUNCIL MEETING

The Ellsworth City Council met in regular session at 6:00 p.m. at City Hall on MAY 12, 2025 with Mayor Yager presiding, and the following council present: Funk, Sogard, Phipps, and Olson. Members of the public present: Barry Anksorus, Andrew Holden, Cody Robertson, Roger Mason, Ron Cook, Brian Zimmerman, Ashely Platte, Kayla Knippel, Jessica Lowe, Jennita Brennan, Officer Kaleb Morton. Staff present: Nick Vanlangen.

AGENDA APPROVAL: Motion by Funk, seconded by Olson to approve the agenda. Roll call votes 4-0. Motion carried.

CONSENT AGENDA: Motion by Funk, seconded by Olson to approve the following items listed on the consent agenda:

- a. Motion to approve April 22nd Minutes and April 28th Special Hearing Minutes.
- b. Motion to approve April payment of Claims.
- c. Motion to approve debt payment to Iowa Finance Authority for SRF Loan in the amount of  
\$95,675.50 plus service fee of \$3,335.00, due June 1st, 2025.
- d. Motion to approve Kum and Go #133 Class E Liquor License and Kum and Go Retail Permit  
for Tobacco Sales. Roll call votes 4-0. Motion carried and claims hereby made a portion of these minutes.

PUBLIC FORUM: Kayla Knippel addressed the Council with questions about how City Boards operate in Ellsworth. Barry Anksorus addressed the Council about the EJS police board. Kalya Knippel addressed the Council with concerns about the morality of the current Mayor. Mayor Yager and Councilman Funk both addressed Ms Knippel questioning the reasoning for her accusation. Both Mayor Yager and Councilman Funk have extensively researched actions taken regarding accusations made in recent Police Board minutes. Legal council was also sought by Mayor Yager prior to taking action concerning the handling of documents referenced in Police Board minutes.

ECA: Ashley Platte was present to update the Council on improvements, ECA volunteers are collaborating with the city staff on two of the city parks. The concession stand at the ball field is getting a facelift, paint, bathroom updates, and Ms Platte has acquired an estimate for a new roof from Thompson Construction for \$3800. ECA hosting a softball game or tournament as a fundraiser was discussed to help offset the cost of the new roof. The City has already purchased paint and has budgeted for other improvement expenses for FY2026. A new sink and new doors were requested as apart of the renovation process at the concession stand.

639 BRINTON EMPTY LOT: Roger Mason was present to express interest in purchasing the empty lot. Mr Mason plans would be to do weed control, mowing, and plant some trees. Motion by Sogard and seconded by Phipps to advertise a 30-day closed bid on the property with a minimum bid of \$5000. Roll call votes 4-0. Motion carried.

DISCUSSION AND POSSIBLE ACTION ELLSWORTH FARMERS MARKET: Jennita Brennan and Jessica Lowe were present to request access to Dewitt Street sidewalk use for the upcoming

weekly Ellsworth Farmers Market, beginning June 4th from 5pm to 7pm. Motion by Funk and second by Sogard to allow downtown Dewitt Street access to the Farmers Market, Wednesdays beginning June 4th through October from 5pm to 7pm weekly. Roll call votes 4-0. Motion carried.

DISCUSSION AND POSSIBLE ACTION ELLSWORTH PARKS BOARD: No board members present

LIBRARY: None present

FIRE/EMS: None present with comment

DISCUSSION AND POSSIBLE ACTION BINGO SCHOLARSHIPS: Council was presented with two applications for Bingo scholarships, Connor Deppe and Neveah Nelson. Both applicants met the GPA requirements. Motion by Funk and second by Olson to award Connor Deppe and Neveah Nelson with a \$500 Bingo scholarship each. Roll call votes 4-0. Motion carried.

DISCUSSION AND POSSIBLE ACTION MIDLAND INVOICE 101 HWY 175: Council discussed previous expansion projects in the industrial park/urban renewal area. Clerk Eckers had David Speed with Midland on the phone to answer questions from the Council. Clerk Eckers will continue to work with Amy Bjork at Dorsey and Whitney to add this property back into the Urban Renewal Area #1. Motion by Sogard and seconded by Olson to pay \$20,000 towards the boring and wire of the Truck Wash project. Roll call votes 4-0. Motion carried.

PUBLIC WORKS: Discussion and Possible action, slow down signs at Ellsworth City Park. Both Mayor Yager and Councilwoman Sogard read public comments they had been asked to share concerning speeding vehicle issues around the city park. These comments suggested stop signs and slow down signs are not being adhered to, but that speed

Supervisor Vanlangen will get a quote from DOT prior to next Council meeting for speed bumps that city staff could install around the park, pending Council approval.

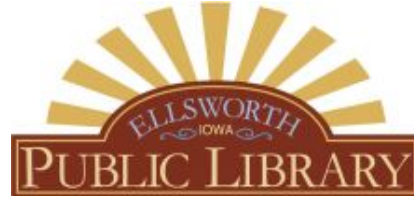

Clerk Eckers will request tax of \$490 be removed from the invoice prior to approval of the improvement. This improvement had previously been approved by the Council, motion and vote not required. Clerk Eckers updated the Council on process to amend the FY 24/25 Budget. After reaching out to the Department of Management Clerk Eckers was made aware amendment was not necessary for FY 24/25 at this time. The previously scheduled proposed Budget

Amendment Hearing on May 27th is no longer required.

ADJOURNMENT: Mayor Yager adjourned the meeting at 8:40 p.m.
